•FINANCE: Sherry Lynn, Treasurer and Chair, gave the following:

NCCEAPA Treasurer's Report March 20, 2015

I received the records for the organization from Ivy Olson shortly after the State Meeting held in September 2015. Ivy also shared access to Google folder containing NCCEAPA financial files. I created a new folder for 2014/2015 and shared access with Sandy Kanupp. I changed authorized account holders at the State Employees Credit Union to reflect the new President and myself.

Donation request letters were sent out in November and to date we have received contributions from NC Farm Bureau \$250 and\$1000 from Carolina Farm Credit which was a pleasant surprise. Follow up letters were sent in February. Letter was submitted to NACAA (Ag Agents Association) for \$1000 support to fund our awards program. We just received \$250 from NCSU foundation - far short of the \$1000 hoped for. This is not reflected in the reports as I just recently received it. Last year we received a total of \$1875 in contributions (NCACAA - \$1000, NCSU Foundation - \$500, NC Peanut & Tomato Growers - \$125 and Corn Growers - \$250).

I have contacted the President and the Treasurer of the North Central District in regards to TERSSA dues issue from last year, requesting that the dues that were collected for the three but that were not submitted to state treasurer be submitted to me at this time so I can send to TERSSA. I received payment from North Central on March 13th and will send check to TERSSA to resolve this issue.

Membership numbers have decreased by 37 and are expected to decrease again this year. We need to continue to explore funding sources and would appreciate the boards input. The money market account will not last too many years if our revenue keeps going down. Our largest expense is travel with a budget of \$5000. The finance committee recommends conserving travel dollars by having the executive board room together when at all possible. Also suggest using NCCEAPA funds for travel reimbursement only if county or state funds unavailable.

OLD BUSINESS

- 2015 STATE MEETING UPDATE: Regina Gardener gave the report on behalf of LaToya Lucy, Southeast District President.
 - -A survey was sent on Jan. 30 via email to gather information as to the reasons that would not enable a person to go and what professional development areas would be of interest.
 - -The district has signed the contract with the Double Tree Hilton for Sept. 23-25 and is locked in to 20 rooms for Wednesday and 60 for Thursday.
 - -Registration will be announced in late April, with early bird registration due July 17 and final deadline, August 14.
 - -Discussion ensued as to why certain professional development programs were allowed at some association state meetings and why they were not allowed at our state association meeting. Different associations have to report to different administrative personnel than we do who will have different opinions. Our association via Sandy Kanupp, will seek more clarification from Sheri Schwab as to possible consistency across associations or if our association has different standards set than others.

NEW BUSINESS

- 2015 FEDERATION DELEGATION: Sandy Kanupp explained the process of invitations to the Federation Forum
 according to the bylaws and past misunderstandings of such. The outgoing officers are invited to the forum, not the
 incoming officers due to the different calendar years of the Federation and NCCEAPA officer installation. In 2015,
 Sandy will document who is invited, who accepts, who declines, and who attends, as well as asking each future
 President of our Association to do the same.

- Sue Bugg asked if there would be special recognition from our association for those leaving due to restructuring. Sandy said a suggestion from a district was sent to the Executive Board to take money from NCCEAPA treasury to give to each district to honor those leaving. Sandy explained that after much discussion with the Executive Board about the uncertainty of budget funds in the upcoming year(s) that the Board determined that it would not be prudent to withdraw funds at this time and that the first priority of the Board is to cover the budget and those in the future.
