

**Minutes - Board of Directors Meeting  
North Carolina Association of Agricultural Extension Secretaries**

**Jane S. McKimmon Center  
Raleigh, NC**

**May 10, 1984**

The Board of Directors of the North Carolina Association of Agricultural Extension Secretaries (NCAAES) met at 10:00 am, May 10, 1984 at the Jane S. McKimmon Center in Raleigh, NC.

State President Joy Marshall presided at the meeting, with thirty-six members in attendance.

Sandra Ballard, 2nd Vice President presented the devotional.

Helen, Vann State Secretary, asked each district president to introduce the members that were present from her district.

The minutes were read and approved with one correction. The correction being that Dr. Dew would meet with Lillian Knight, Mariah McPherson, and Joy Marshall to outline topics for the State meeting to be held September 18-19, 1984 in Raleigh, N.C.

Earla Moore, State Treasurer gave her report showing a balance on hand of \$536.25.

The 1985/86 scholarship will go to the Northwest district.

There was a discussion on honorary and associate membership in the organization. Send names and qualifications for either to the state president.

An Associate member pays dues to the association and request to continue to be a member of the NCAAES. She is no longer employed with Extension Service.

An Honorary member of the NCAAES is to be voted as an honorary member for having been an outstanding person in the association and has taken an active part. She would not pay dues.

Lou Lakey, chairman of nominations gave the following report:

1. Each district asked to send an updated list including which office each person has held) to State Public Relations chairman, Ernestine Talley, Person County by June 15 to be included in the State Newsletter.
2. Nomination forms will be sent with State Newsletter and should be returned to Nominating Committee chairman by August 20.
3. Second Vice President should come from the Southwestern District. The secretary and treasurer can come from any district.

Joy Marshall, explained the "State Of The Future". N.C. State University has a fund raising drive and the employees of the college will be receiving information on the drive.

Joy Marshall asked all district secretaries to send minutes of the District meetings to the State President. In that way, the president will have ideas of the progress throughout the state.

An invitation was extended that the 1985 NCAAES meeting be held with the Western District as the host. They will have a date for the 1985 meeting when we meet September 18-19, 1984 for the state meeting in Raleigh, NC.
