Minutes - Board of Directors Meeting North Carolina Cooperative Extension Secretaries Association

February 17, 1995

Devona Beard called the meeting to order at 10:00 a.m. She recognized Karen Whitley, Advisor, as the parliamentarian for the meeting. Devona then recognized Dr. Everette Prosise, Interim Asst. Director for County Operations, who brought greetings to the group. Everette told the group how important they are to the organization. He spoke to the group about separating the training session in 1996 from the Association Annual Meeting. He mentioned that they might want to consider other sites than Raleigh for the training - that it was their training and it could be held elsewhere. He stands ready to assist the Association in any way possible.

Dr. Billy Caldwell, Interim Associate Dean and Director, was then recognized. He also recognized the importance of support staff. Devona will send information to the Public Relations Chair for inclusion in the newsletter and asked that all members pass the newsletter on to all retirees.

NEW BUSINESS

FUND-RAISER - Dr. Dalton Proctor has donated a 4-H gnome to raffle off at State Meeting. Dr. Proctor will be present. Mona Rodgers will be in charge of the fund-raising.

BENEVOLENCE PLAN - Recommendation: \$50 memorial will be sent to favorite charity in memory of the member - Discussion followed. Devona called for a motion. Sandra Smith-Hopkins made a motion that we contribute \$25 to a favorite charity in honor of deceased member; seconded by Pat Sykes. Motion carried. Districts should contact Christine Barrier regarding death of member.

HORN OF PLENTY - Secretaries Association asked to contribute the beverages. The Executive Board felt it would be easier for all districts to send monetary contribution of \$20 to cover all beverages. Discussion followed. Nancy Miller make a motion that each district would contribute \$25 toward beverages for the Horn of Plenty event. Seconded by Sandy Kanupp. Motion carried. Checks are to be forwarded to the State Treasurer.

The Association has been asked to contribute \$1.00 per member toward the Horn of Plenty fund. This will be discussed at the district meetings and will be handled at the discretion of each district. Letters from the Horn of Plenty Chair were distributed.

SPECIAL AWARDS - There has been discussion since the State Meeting about the reason for two separate state awards for the Computer Utilization and Special Leadership between the districts and the campus chapter. Some felt that the campus chapter receives more opportunities for special training and seminars not afforded to the districts; others felt that all the secretaries should be considered together. Devona wrote to Dr. West before his retirement and received approval to have one overall state winner in each category.

1996 STATE TRAINING - Separate dates for the State Training (held every four years in Raleigh) and the Association State Meeting was discussed by each district. It was decided that there should be separate dates for each meeting. Three issues needed to be decided and voted on today.

Sue Mills will meet with the committee members immediately following this meeting to decide on a planning meeting date.

1995 STATE MEETING - Devona invited Beverly Imes of the Southwestern District to come forward to discuss the 1995 State Meeting in Charlotte. Beverly announced on behalf of the Southwestern District that the 1995 State Meeting of the N C. Cooperative Extension Secretaries Association will be held at the University Hilton in Charlotte on Thursday and Friday, September 28 and 29. Exciting things planned include tours of Charlotte Motor Speedway and Discovery Place in downtown Charlotte. Theme is "The Winning Team." Each district president should see Kathy McAteer to get their packet concerning the state meeting.

OTHER BUSINESS:

Karen Whitley has been asked to serve on the marketing committee for the next two years. She asked that any marketing ideas be shared with the committee.
