

Minutes NCCESA Campus Chapter Orange County Extension Center August 14, 2012 1 p.m. - 4 p.m.

**Roll Call:** Ten members were present – Andrea Brooks, Margaret Browne, Tracy Brown, Geri Bushel, Karla Frizzelle, Susan Graham, Donna Holland, Suzanne Hugus, Vicky Merritt, and Anita Wright.

**Approval of the Minutes:** Members were asked to review minutes. A few minor changes were noted for correction. Tracy Brown made a motion to accept minutes with corrections. Karla Frizzelle seconded the motion (motion was carried).

She stated that she hasn't been the best chair but that they've kept her on task as well as made sure that all tasks were done.

**Nominating:** Vicky Merritt reported that the committee's main purpose is to seek nominations for the 2012-2013 year and present a slate of officers at the last meeting of the current year. An email was sent to members for a Call for Nominations on June 25, 2012 with a deadline of July 20, 2012. A reminder email was sent out to members on July 17, 2012 along with a Call for Nominations for the Federation 2<sup>nd</sup> Vice President, NCCESA State Secretary, and NCCESA State Treasurer. We received 1 nomination for 2<sup>nd</sup> Vice President, 3 nominations for Secretary, and 1 nomination for Treasurer. One of the nominees for Secretary withdrew her name prior to the business meeting. A secret ballot election was conducted for the office of Secretary and it was a tie vote 5-5 for Andrea Brooks and Margaret Browne. After discussion, the membership agreed that Andrea Brooks will serve as Secretary with Margaret Browne as Secretary Elect and will shadow Andrea this year to learn more about the duties of the secretary.
