# North Central District Cooperative Extension Administrative Professionals Association (NCDCEAPA) Fall Meeting October 26, 2012

Kay Evans of the host county welcomed the group and gave housekeeping instructions.

Pam Jordan-Carrington, District President, called the meeting to order.

Dr. Carl Matyac, Orange County Extension Director, welcomed the group on behalf of the entire staff. He only became aware of the association when he became director and said it is good to take time to do your own examination of what you do. He said secretaries don't get daily reinforcement from clients that agents do, and thanked us for all we do.

Sandy Ruble, First Vice President, gave the Thought for the Day, emphasizing excellence and decision-making. Maybe continue the gift cards because Nancy and others still think it's a good way. Carla will put suggestions on Facebook.
