

#### South Central NCCESA Spring Meeting April 25, 2008 Columbus County Lake Waccamaw, North Carolina

The 2008 spring meeting of the South Central District NCCESA was held in Columbus County at the Boys and Girls Homes in Lake Waccamaw, North Carolina.

Leeann Crump, President, called the meeting to order. Leeann thanked Nan Rackley, Linda Brulet, Linda Duncan, Ann Pridgen, and the Columbus County staff for all the hard work and efforts made in hosting the meeting.

Leeann led the group in the pledge of allegiance, followed by Susan Johnson, 1<sup>st</sup> Vice President, providing an inspirational message.

Dr. Donald Cobb, DED, was introduced by Leeann. He echoed his appreciation for all Administrative Professionals and thanked the secretaries for the good job they do for

Cooperative Extension. He said change was inevitable and welcomed Cabarrus and Union Counties aboard as well. Dr. Cobb said he appreciates the opportunity to be a part of the South Central District. He then asked for any questions from the floor.

Janet Mabry, Stanly County, asked if there had been any further discussion at the administrative level concerning the issues with the new templates. Dr. Cobb indicated that Crystal Bartlett was aware of the issues of concern and that Clinton McRae, Richmond County CED was scheduled to share the problems at the next Extension Council meeting. To Dr. Cobb's knowledge there has been no response as to how or when the problem will be resolved.

Denese Prevatte, Robeson County, asked if there were any plans to print the newsletter template so that it could be purchased by counties. Dr. Cobb was unsure.

Debbie Humphrey, Robeson County asked if new name tags with the current logo will be made available. Dr. Cobb said they should be. Jackie Roseboro, Columbus County CED, introduced Bill Thompson, Former CEO of the Boys and Girls Homes; Tom Lamont, Director of the Civic Clubs; and Rev. John Cobb, Chaplin of the Boys and Girls Chapel.

Bill Thompson thanked the group for making a difference. He appreciated the opportunity of speaking to the secretaries in Southern Pines and from that engagement has received several speaking opportunities. A scholarship through NCSU or NC A & T State University has been established in his name and is available to students majoring in the field of agriculture.

Tom Lamont then divided the group and took half of the Secretaries on a tour of the Boys and Girls Homes campus, farm, Country Store, cottages, and facility.

Rev. John Cobb conducted a tour with the others at the Chapel. Both group leaders shared the history of the Boys and Girls Homes along with interesting information and facts. They currently serve 14 counties with 60 residential youth and 106 supervised foster care youth. Groups exchanged places so everyone had the complete tour.

The groups reconvened at Dale's Seafood for a delicious lunch, along with three million May flies, which were anxious to greet us. Leeann asked each person to have their own invocation as they saw fit. After the meal, we walked on the pier at Lake Waccamaw, what a beautiful place!

# **UNFINISHED BUSINESS**

SRERSSA (Southern Regional Extension & Research Support Staff Association)

Devona Beard, SRERSSA Planning Committee Chair, gave an update on the first regional secretaries' conference to be held in Nashville, Tennessee on November 12-14, 2008. Each secretary was given a packet of registration information and encouraged to support this event.

Leeann stated that additional funds to support this first regional conference were needed; a motion had been made and passed at the State Board Meeting in Raleigh for each county in North Carolina to contribute \$100 towards this effort. She asked for discussion in sending more money.

Devona said the Regional membership fee overage may be around \$30 (the exact amount to be voted on at the meeting in November) per secretary. That money will help fund association operating expenses for the next regional conference, however, more funds are needed for this year because it is the first year for this type of meeting. Devona stated that our South Central District secretaries association has already sent \$500, with an additional \$300 collected on the county level for a total of \$800. She made a motion that the South Central District send the remaining \$700 from the Money Market Account to comply with the request of the State Board. The motion was seconded by Janet Mabry; funds will be mailed to Donna Fulp, SRERSSA President, to be used for conference expenses. The South Central District's 15 counties have now contributed a total of \$1500 to SRERSSA for the 2008 Regional Conference.

# **NEW BUSINESS**

Denese Prevatte has inquired about the future use of the Red Brick letterhead. She found that the Red Brick letterhead is to be used for all letters except for those multiple topic newsletters that would go on the new template. The new newsletter template does not have to go on the Red Brick letterhead.

Leeann said Susan Graham gave her three yellow shirts left over from the state meeting with the logo on them. These will be available for \$10 each; first come, first served.

Nan told everyone there would be a snack and drink from the Columbus County Secretaries to take when they leave the meeting. The Columbus County secretaries also made the lovely sweet potato necklaces given to each secretary in their abundant goody bags at the meeting.

The four retirees were recognized and a thank-you card was read from Thetis Williams for the retirement gift given to her by the South Central District.
